surprise and uncomfortable feeling when he announced his intention of stopping at the McCanles home. I would have rather been somewhere else, but Bill stopped. He told Mrs. McCanles he was sorry he had to kill her man then took out \$35.00 and gave it to her saying: 'This is all I have, sorry I do not have more to give you.' We drove on to Beatrice and at the trial, his plea was self-defense, no one appeared against him and he was cleared. The trial did not last more than fifteen minutes."
