a Kia, but I let it slide. The next day I happened to look at the paperwork and they were charging not \$35 a day, but \$85 a day. I blew up. We returned the car that evening. They acknowledged a mistake had been made but insisted on charging us \$85 for the first day. Which they did. But they lost a car rental customer forever. We will not rent from Enterprise again. On an earlier trip to Alabama we had to jump through a number of unnecessary hoops just to turn the car back in. We had rented it the night before for a one-way trip from Birmingham to Montgomery, placed it in valet parking, returned it the next morning. Montgomery claimed there was a scratch on the bottom of the right (passenger) side. Couldn't have been. The car was hardly used by us. We finally got the car turned in but it was an unpleasant experience.
