More than 100 firefighters, lifeguards and law enforcement officers from numerous agencies raced to the beach to launch a rescue operation. Lifeguard and Coast Guard boats combed the sea for survivors, while at least three helicopters shined searchlights from above.

Six passengers were taken to hospitals with various injuries, including a man who was pulled from the water and later died. One was in critical condition, and three were released by Saturday night, according to authorities.

All 16 people who were rescued are Mexican nationals who were entering the United States illegally, authorities confirmed. It was the third time in three weeks that authorities have assisted smuggling boats in distress, the Coast Guard said.

The smuggling trips, which can be several hours long in uncomfortable conditions, typically cost a passenger \$3,000 to \$5,000.
