An ICE Agent partnered with an Escondido Police Officer was able to give specific directions and turn by turn instructions that tracked the suspect. With the help of ICE agents assigned to the Escondido Police Department, the suspect was located and safely taken into custody on the burglary charges. Without this technology and the assistance of the ICE Agent, the suspect would not have been located.
