Democrats' Tax Hikes Hit Middle-Class Pocketbooks

A new report released this week showed that Californians' personal incomes dropped by a shocking \$40 billion dollars last year. This is the first decline in personal income in California since World War II.

Surprise! Escondido Mayor Pfeiler retiring as Mayor . . . but Throws Bonnet into Council Race

On the final day of candidate filing, Mayor Lori Holt Pfeiler of Escondido reversed her field and, though she is stepping down as Mayor, opted to run for a Council seat instead.

It's beginning to get crowded in both the Mayor's and Council races. Also, earlier favorites are now wondering if their chances at winning have been hurt by Pfeiler's entry. She has name recognition and generally enjoys popular support, even from her political opponents.

Pfeiler, who joined the council in 1992 and was first elected mayor in 1998, said she decided within the past couple of weeks to run again. "There are a lot of exciting things going on in the city, and I decided I could still be a positive force," said Pfeiler, 53.

Pfeiler is a supporter of the controversial plans for a minor league ballpark, a proposed technology business park and efforts to revise the city's development blueprint for the first time since 1990.

Pfeiler's entry brings the num-

ber of candidates seeking two open council seats this year to seven.

The other candidates are incumbent Councilwoman Marie Waldron, local contractor Jim Crone, former Councilman Ed Gallo, public policy analyst Jason Everitt, businessman Richard Barron and activist Carmen Miranda.

Gallo said he was surprised Pfeiler would be willing to "step down" into a council seat after serving so long as mayor.

Waldron said Pfeiler's presence creates an opportunity for voters to preserve the council's current lineup, which she described as well-balanced and pro-business. If Pfeiler and Waldron win council seats and Councilman Dick Daniels wins the mayoral race, the council would feature no newcomers next year.

Crone said Pfeiler's presence made the race even more of a referendum on the current council, which he has criticized for overspending and making poor economic development decisions.

"I'm going to run on my record and hope that people think I still bring value to the council," Pfeiler said. "I hope my 18-year record distinguishes me to people."

That may well happen but she's way behind in fundraising.
